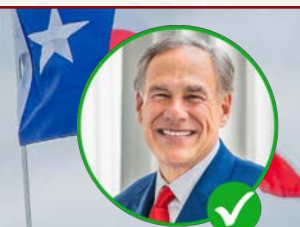

# STANDING UP TO LAWFARE: WHY REPUBLICANS MUST RALLY BEHIND KP GEORGE IN FORT BEND COUNTY



Why is TCR supporting County Judge KP George? As a conservative publication that has seen the weaponization of our justice system unfold across Texas and the nation, we are compelled to speak out in defense of Fort Bend County Judge KP George. This dedicated public servant, now running for re-election as a Republican in the March 3, 2026 primary, is the latest victim of brazen political prosecution—or as we’ve come to know it, “lawfare.” It’s a tactic the radical left deploys to silence conservatives, and it’s time for Fort Bend Republicans to stand firm and send George back to his post.

Let’s cut through the noise: KP George, a lifelong advocate for fiscal responsibility, public safety, and family values, switched to the Republican Party in June 2025 after years of clashing with Democrat insiders. Elected as County Judge in 2018 and re-elected in 2022, he’s delivered results—bolstering emergency management post-Hurricane Harvey, cutting wasteful spending, and prioritizing infrastructure in one of Texas’s fastest-growing counties. But his real “crime”? Daring to challenge the status quo and align a decidedly conservative ideology.

Enter rogue Democrat District Attorney, Brian Middleton, a George Soros-backed puppet who received hundreds of thousands in campaign cash from entities tied to billionaire George Soros—reportedly over \$700,000 through PACs like Texas Justice & Public Safety. Soros, the

kingpin of left-wing chaos, funnels millions to install soft-on-crime prosecutors who target political foes while letting actual criminals roam free. Middleton’s indictment of George on trumped-up money laundering charges and a misdemeanor for alleged campaign misrepresentation reeks of desperation. It’s no coincidence this hit came as George eyed re-election; it’s classic lawfare, designed to smear and sideline a rising conservative voice.



This isn’t new. Remember Congressman Tom DeLay? The powerful Texas Republican was hounded by Democrat prosecutors on

bogus money laundering charges in 2005, forcing him from leadership. After years of legal battles, he was exonerated—but the damage was



done. Or Governor Rick Perry, indicted in 2014 for vetoing funds to a Democrat DA’s office. That witch hunt collapsed in 2016, exposed

as pure political vendetta. And who could forget President Donald Trump, battered by endless sham investigations from New York to Georgia, all orchestrated by Soros-



funded DAs like Alvin Bragg and Fani Willis? Trump’s “crimes” were fighting for election integrity and America’s borders—sound familiar?

KP George’s case fits the pattern: A conservative leader targeted to suppress dissent. Middleton’s office

has been accused of misconduct, including deleting evidence and cutting deals with witnesses, prompting calls for his disqualification. Even a criminal investigation into Middleton himself is underway, as revealed in recent court filings. This isn’t justice; it’s election interference.

Fort Bend Republicans, don’t let the left divide us. George’s opponents in the primary peddle the same tired smears, but true conservatives know a fighter when we see one. He’s pro-law enforcement, anti-waste, and committed to fiscal responsibility. In his seven years in office, there has been no tax rate increase and KP George brought in a staggering \$600 million in grant money to help fund infrastructure priorities at no cost to taxpayers. In 2025 he led the effort to redistrict Commissioners Court and turned the court RED. He also killed Fort Bend County’s DEI program. KP George even voted against the last budget with its \$39 million in deficit spending. This is leadership that has driven the left crazy. But it is leadership that resonates in our diverse, booming county. Voting for KP George isn’t just supporting a candidate; it’s rejecting lawfare and reclaiming our courts from radical ideologues. Remember, if they can do this to KP George, they can do it to any one of you, which means none of us are safe.

On March 3, make your voice heard. Re-elect KP George, a proven conservative who needs no “on-the-job-training” and show the Soros machine that Texas conservatives won’t back down. ★
